REGULATION

ART. 1 - ORGANIZATION AND PURPOSE

The 3rd European Piano Competition "Salentinae Terrae" is organized by A.GI.MUS. - Associazione Giovanile Musicale - Francavilla Fontana Section - and aims to promote musical culture, musical institutions, young and very young musicians, as well as the city of Francavilla Fontana, the County of Brindisi and all Region of Puglia.

This Competition has the Patronage and Collaboration of the Department of Culture of the City of Francavilla Fontana, as well as the patronage of MIUR - Ministry of Education, University and Scientific Research -, MIC - Ministry of Culture - and the Municipal Music School "City of Francavilla Fontana", as well as the valuable and prestigious support of companies such as AGIC TECHNOLOGY, SOAVEGEL, DEA and GUARINI DISTRIBUTORI AUTOMATICI. Musical Youth Association "A.Gi.Mus" is accredited to the F.U.S. (Fondo Unico della Spettacolo) established by the MIBACT - Ministry of Artistic, Cultural and Tourism Heritage.

ART. 2 - MODALITIES AND TIMING

The 3rd European Piano Competition "Salentinae Terrae" will be held in two modes, at the candidates' choice, namely "in presence" and "online". The mode of participation will be indicated by the competitors at the time of their registration. The Competition will take place in Francavilla Fontana, at the Auditorium of the Municipal Music School, via Trento - via d'Annunzio, on Sunday, March 19th, 2023.

ART. 3 - ENROLLMENTS

Applications for the 3rd European Piano Competition "Salentinae Terrae" must, for all, (both "in-person" and "online") be submitted no later than TUESDAY, MARCH 14th, through the completion of an online form specially prepared on the official website of the competition, at the following address www.agimusfrancavilla.com. Applicants who opt for the "online" mode of participation are required to send their files no later than Saturday, March 13th, 2023, through the platform we transfer to email destination agimusfrancavilla@gmail.com, or by sending the link following uploading on their own on any YouTube channel.

Category	"C"	for those born in 2007-2008-2009	- maximum duration of the test: 15 min.
Category	"D"	for those born in 2004-2005-2006	- maximum duration of the test: 18 min.
Category	"E"	for those born in 2001-2002-2003	- maximum duration of the test: 20 min.
Category	"F"	for those born in 1998-1999-2000	- maximum duration of the test: 25 min.
Category	"G"	for those born until 1997 without age limit	- maximum duration of the test: 30 min.

ART. 6 - PROGRAMS

The performance program is free and, therefore, the candidate's exclusive choice.

ART. 7 - INDICATIONS FOR MAKING THE VIDEO EXECUTION AND METHOD OF SUBMISSION

The Candidate who intends to participate with the "online mode" is required to make a video recording of his/her competition program, taking care to:

- A) Save the file, or files, in MP4 format;
- B) Comply with the prescribed minute length in his or her category;
- C) Do not make audio-visual cuts and/or manipulations;
- D) The framing to be used during the recording must allow for the recognition of the candidate and make the upper and lower limbs visible;
- E) The files must be named with

1. SURNAME AND NAME OF CANDIDATE;
2. NAME AUTHOR BRANCH;
3. TITLE BRANCH.

ART. 8

Entry fees are not refundable under any circumstances, unless the contest is cancelled.
In that case, the entry fees will be refunded in full.

ART. 9 - COMMISSIONS

The Commission will consist of musicians and teachers of clear reputation and proven experience.

ART. 10 - PRIZES

1st Absolute Prize: The competitor with a score of 100/100 will receive the Certificate of 1st Absolute Prize.

1st Prize: The contestant who has achieved a score between 95/100 and 99/100 will receive the Certificate of 1st Prize;

2nd Prize: The contestant who has achieved a score between 90/100 and 94/100 will receive the Certificate of 2nd Prize;

3rd Prize: The contestant who has achieved a score between 85/100 and 89/100 will receive the Certificate of 3rd Prize.

Awarding of Prize Concerts

At the end of the competition the commission may assign to those competitors (both soloists and formations) who have particularly distinguished themselves, on its own unquestionable indication, up to n. 6 concerts, to be held as part of the 2024 Artistic Season of the A.Gi.Mus - Francavilla Fontana Section.

ART. 11

All Trials of the Competition may be broadcast by radio and television stations, or published on social platforms, without entitlement to compensation.

ART. 12

If necessary, the Organizers reserve the right to make changes to these regulations. In this case the contestants will be promptly informed.

ART. 13
