# String quartet composition contest "Abramo Basevi"

# I<sup>st</sup> Edition 2019 "Robert Schumann gewidmet"

The Florence Quartet Society (Società del Quartetto di Firenze), rebuilt in 2014 by the Quartetto Foné, wishing to promote further interest around the string quartet repertoire and its diffusion, announces an international string quartet composition contest.

Robert Schumann's musical poetics will be the contest's theme reference point. Selected compositions will be presented live in Teatro della Pergola (Florence) within the 2018 -19 Amici della Musica di Firenze season, as final event of the "Sensucht" project (complete performance of Schumann's string quartets).

Abramo Basevi, Florentine musicologist, composer and founder in 1862 of the first Italian "Società del Quartetto", organised a "Concorso annuale di composizione" (Annual composition contest) between 1861 and 1864, dedicated to string quartet. Renowned musicians such as Giovanni Bottesini and J. B. Charles Dancla, as well as promising but still unknown European composers, took part in this contest.





# CONTEST RULES

#### Art. 1

Participation is open to musicians from all over the world, with no age, composing aesthetics or technique restrictions.

#### Art. 2

Compositions have to be written for a string quartet ensemble, eventually with the help of electronic devices, keeping in mind that the performers have to be the members of a string quartet.

#### Art. 3

Compositions have to be unreleased, and performed in Italy for the first time.

#### Art. 4

Compositions must be max. 7 minutes long.

#### Art. 5

Score and parts must be delivered only in PDF file format; it is recommended to send an audio file (midi or mp3).

#### Art. 6

All mentioned in art. 5 must be mailed within 01/31 2019 to info@quartettofone.it; files larger than 5 Mb must be shared via Wetransfer, Dropbox, Googledrive or other.

#### Art.7

Admission requests must contain the application form, filled in any part: signing a disclaimer for all eventual performances, broadcasts, audio and video recording by Quartetto Fonè is mandatory.

#### Art. 8

The selection of the compositions to be awarded is an unappealable decision by Quartetto Fonè, which will also perform the above compositions.

## Art. 9

Awarded compositions, no more than three, will be presented in concert at the Teatro della Pergola in Florence on April 6th, 2019 for Amici della Musica di Firenze, as final event of the "Sensucht" project (Full performance of Schumann's string quartets) promoted by Quartetto Foné.

## The following documents have to be attached to the admission request:

- 1) 1) Application form, filled in all its parts and signed, including the mandatory disclaimer.
- 2) Short school and artistic CV (within 30 lines);
- 3) Brief introduction to the composition (within 10 lines);
- 4) A copy of a valid ID form of the composer.
